GAME DAY INFORMATION GAME STARTING TIMES

Games will begin promptly at 6:30 pm. (Playoff games could start at 6:45 with Conference Supervisors approval). If either team is awaiting the arrival of their 8th player, a 15-minute grace period will be extended. When that player arrives, that team has the OPTION to start the game with eight or they can await the arrival of their 9th player within the 15-minute grace period. Once the grace period expires, the 8 must start. If within the grace period, the 9th player arrives, the game MUST begin. If the grace period expires and the 8th player has not arrived, a forfeit is called against the shorthanded team. **CROSS CONFERENCE GAMES RECEIVE A 30 MINUTE GRACE PERIOD and MUST start when the Ninth (9th) player arrives**

GAME SOFTBALLS

Two League sanctioned softballs are to be supplied for each game by the home team.

LEGAL GAME DAY CANCELLATIONS

Cancellations due to inclement weather must be made **before 3:30 pm** by the home team manager notifying the ASA Assigner **Ed McKeown at (H) 669-5999**. Home team manager is also responsible for notifying Away Team Manager and Conference Supervisor of a cancellation before 3:30 pm. 'NO FIELD' is **not a legal GAME DAY reason** for a cancellation. **The Home Team is responsible for securing an approved field or they will get a FORFEIT LOSS.** Cancellations not due to weather must be made 24hrs before game time.

ILLEGAL GAME CANCELLATIONS

If a game is cancelled for any reason other than inclement weather with less than 24 hours notice, the league will be billed for the entire umpire fee of \$42 which in turn will be deducted from the home teams' performance bond.

RESCHEDULING GAMES

From the day of cancellation, the home team manager will have 7 days to provide a make-up date to their Conference Supervisor. If a date is not called in within 7 days, the Conference Supervisor will schedule the make-up game for the first available Monday, Tuesday or Thursday that both teams are not playing and when the home field is available.

SCORE REPORTING

All scores are to be called in by the winning manager to the SCL Scoreline at **207-8302** before 9:30 pm on the night of the game. Failure to report a score on game night, or later than the 9:30 pm deadline will result in performance bond forfeiture (for the first offense) and a 7-0 forfeit against the winning team (for the second offense).

WESTERN CONFERENCE

NORTHPORT BAPTIST APOSTLES Harley Avenue School East Northport

Take LIE to Sunken Meadow Pky. North to Jericho Tpke. (Rte. 25) going west. Go west for 1½ miles and make a right (North) onto Larkfield Road. Go north for 1 mile and make a left (west). Harley Ave. School is at the end of road on right. Field is back on left.

DIX HILLS ANGELS DIX HILLS SERVANTS Half Hollow High School West Dix Hills

Northern State Parkway to Exit 41. Go east on Wolf Hill Road. School and parking lot are on the left.

SAYVILLE METHODIST SERAPHIM Sayville Middle School Sayville

Sunrise Hwy. (Route 27) to Johnson Ave. South on Johnson Ave. about ¼ mile. School is on left. Field is in back of school.

FIRST PRESBYTERIAN WITNESSES Babylon Memorial Grade School Babylon

Southern State Parkway to Exit 39 south (Deer Park Ave.). Cross over Sunrise Hwy. (Route 27), then go 1 mile to 1st traffic light. Turn right onto Park Ave. School is ¼ mile down on the right. Pass the school and turn onto Ralph Ave. for best parking lot access.

ISLIP METHODIST PROPHETS Islip Terrace Early Childhood Center Islip Terrace

Sunrise Hwy. (Route 27) to Exit 46 (Carleton Ave.). North to 2nd traffic light (Nassau Ave.) and make a right. Go to end and the field will be located directly in front of you.

CLEFT of the Rock / Christian REFORMED FALCONS (Dual Church Team) Commack High School North Commack (After June 1st)

Take Commack Road (LIE exit 53 or Northern State exit 43) north past Jericho Tpke (RTE. 25). Take the 4th right after Jericho onto Scholar Lane. The school is immediately on the left. Use the last entrance next to the track and tennis courts.

Sunrise Hwy. (Route 27) to Wellwood Ave. south. Go south on Wellwood, past railroad tracks. School is 1/3 mile down on left. Park behind school.

NEW VILLAGE CRUSADERS New Village Field, Lake Grove Middle Country Road (Route 25) to Elliot Ave. North on Elliot Ave. to Wildwood Ave. (1st stop sign). Make left onto Wildwood Ave. to church/field.

TRINITY LUTHERAN REVELATIONS Commack Road Elementary School Islip

Sunrise Hwy. (Route 27) to Commack Road (one exit west of Rt. 111 on service road). Go ½ mile north on Commack Road to school. Make left into parking lot. Field is behind school.

BETHEL LUTHERAN BELIEVERS Stimson Middle School Huntington

LIE or Northern State Parkway to rte 110 North. Continue to Jericho Tpke. (Route 25) Make left (west) to Oakwood Rd. Make right. About ¼ mile on left is school. Field in back on left.

Sunrise Hwy. (Route 27) to Exit 61. Right at stop light onto Eastport Manor Rd. Go about 1 mile to Montauk Hwy. Left at stop sign Go about 1 mile to Tuttle Ave. (just pass school). Turn left. Parking is available off-road or in school parking lot. Fields are in back of soccer fields (a walk of some distance)

GRACE GOSPEL FAITH QUEST PATCHOGUE NEW CREATION (Monday & Tuesday) PATCHOGUE RIGHTEOUS BROTHERS (Tuesdays only) Saxton Avenue Middle School Medford

Sunrise Hwy. (Route 27) to Route 112 and go north to Clark St. Make first left onto Annanias, which ends at Saxon Ave., the school is straight ahead.

LIE to Exit 64 (Rt. 112) south. Take 112 south to Southaven Ave., make left. Go about 3 miles and the field is on right side. Sunrise Hwy (Route 27) to Rt. 112 north. Take Route 112 north to Woodside Ave., make right (East). Go to Sipp Ave. make left. Then make right onto Southaven Ave. (Firehouse is on corner). Take Southaven Ave. east, field will come up on right side.

Sunrise Hwy. (Route 27) to Exit 63 South. Go about 1½ miles to Montauk Hwy. (Rt. 27A). Make a right heading west, go passed Jerry Chi's restaurant to next traffic light (Lilac) make a left. Proceed to driveway on left. Pull into back on right.

LIE to Exit 62 (Nichol's Road) North. Cross over Route 25 (Middle Country Rd.) to Mark Tree Road. Make left (west) to 1st traffic light (43rd Street), make left. School is on the left and field is located behind the administration building.

PATCHOGUE MIGHTY WARRIORS Airport Field #8 Shirley

Sunrise Hwy. (Route 27) east to Exit 58 north (William Floyd Pkwy.). Go ½ mile and make right onto Dawn Drive. Complex on left. Field is in back right corner. L.I.E. to Exit 68 (William Floyd Pkwy.). Go about 2 ½ miles and make left onto Dawn Drive. Complex on left. Field is in back right corner.

BAYPORT/PATCHOGUE UNITED METHODIST SOULS (Dual Church Team) James Wilson Young Middle School Bayport

Sunrise Highway (Route 27) to Nicolls Rd. South look for signs for Purick St. Make right onto Purick, follow Purick directly into parking lot. Middle School is on right. Field is directly behind the School.
