



# 2024 OFFICIAL LEAGUE Game Day Guide



## GAME DAY INFORMATION AND START TIMES

Games will begin promptly at 6:30 pm (Playoff games could start at 6:45 with Conference Supervisor's approval). If either team is awaiting the arrival of their 8th player, a 15-minute grace period will be extended. When the 8th player arrives, the game **must** start. If and when the 9<sup>th</sup> and 10<sup>th</sup> players come, they can be added, as soon as they are ready, anywhere in the line-up that has not had an at-bat yet. If the grace period expires and the 8th player has not arrived, a forfeit is called against the shorthanded team.

**April games will have 1 and 1 count. Starting May 1<sup>st</sup> all games will have a 1 and 1 count with an extra foul.**

## GAME SOFTBALLS AND PLATE MATS

Two League sanctioned softballs are to be supplied for each game by the home team. Both teams are responsible for bringing a plate mat to the field. The home team is required to put out the plate mat. If they don't have their plate mat, then the visiting team is required to put out the plate mat. If the game is played with the visiting team's plate mat, they become the home team for that game. If both teams do not have a plate mat, then both teams receive a forfeit for the game. **No game should be played without a plate mat behind home plate.**

## LEGAL GAME DAY CANCELLATIONS

Cancellations due to inclement weather must be made **before 3:30 pm**. The home team manager must notify the USSSA assigner Floyd Bassett at 631-582-4383. Home team manager is also responsible for notifying Away Team Manager and calling or texting Ken Gesseck (631)355-9924 to report a cancellation before 3:30 pm. **'NO FIELD'** is **not a legal GAME DAY reason** for a cancellation. **The Home Team is responsible for securing an approved field or they will get a FORFEIT LOSS**. Cancellations not due to weather must be made 24 hrs. before game time.

## ILLEGAL GAME CANCELLATIONS

If a game is cancelled for any reason other than inclement weather with less than 24 hours notice, the league will be billed for the entire umpire fee of \$50 for USSSA. That fee will be deducted from the home team's performance bond.

## RESCHEDULING GAMES

When a game is cancelled, the home team manager and the visiting team manager will have until midnight of that day to schedule a make-up date and call it in to Ken Gesseck (631) 355-9924. If a date is not called in by midnight, the Conference Supervisor will schedule the make-up game for the first available Monday, Tuesday or Thursday that both teams are not playing, and when the home field is available.

## SCORE REPORTING

All scores are to be TEXTED in by the winning manager to Ken Gesseck (631)355-9924 before 9:30 pm on the night of the game. Failure to report a score on game night, or later than the 9:30 pm deadline will result in performance bond forfeiture (for the first offense) and a 14-0 forfeit against the winning team (for the second offense).

## MASK RULE

Reminder: All pitchers **MUST** be wearing a mask in order to be allowed to pitch, NO EXCEPTIONS!

**All game night rule infractions, umpire no-shows or any other problems are to be reported to your Conference Supervisor that night by both managers.**

Sunrise Highway (Route 27) to Nicolls Rd. South look for signs for Purick St. Make right onto Purick, follow Purick directly into parking lot. Middle School is on right. Field is directly behind the School

## **INTEGRITY CHURCH (INT) MISSIO MESSENGERS (MM)**

**Twelve Pines Park, Medford**

**270 Southaven Ave. Medford, NY 11763**

From LIE to exit # 64. Go south on Rte 112. Turn left onto Southaven Ave, Take Southaven Ave. approx. 1.5 miles, field is just past fire house on right.

From Sunrise Hwy. to exit 53. Go north on Rte. 112. Turn right onto Southaven Ave. Take Southaven Ave. approx. 1.5 miles, field is just past fire house on right.

## **CORNERSTONE BIBLE COALITION (CBC)**

Nesconset Hwy. (Rt. 347) to Jayne Blvd. south (just west of Rt. 112). Go south about 1-2 miles down on right side. Field is behind church.

## **FIRST PRESBYTERIAN WITNESSES (FPW)**

Southern State Parkway or Sunrise Hwy to Deer Park Ave. (south) take to Park Ave. and make a right (Dairy Barn will be on the corner) stay on Park Ave. for approx. 1/3 mile pass school on right then turn right on Ralph Ave. for best access to parking lot.

## **THREE VILLAGE BRETHREN (TVB)**

**Coed Park, Stony Brook  
2-6 Coed Lane, Stony Brook, NY 11790**

Head West on Rt. 347/Nesconset Hwy. from Nichols Rd. (Rt. 97). Turn right onto Stony Brook Rd. then turn left onto University Heights Dr. Park is on the southwest corner of Coed Ln. and University Heights Dr. Please park along park's border, and NOT along residences and/or driveways.

From L.I.E. to Exit 68 (William Floyd Pkwy.). Go south about 2 1/2 miles and make left onto Dawn Drive. Complex on left. Field #8 is in back right corner.

From the East: Sunrise HWY to exit 51, take Broadway Ave (South) about 1 mile fields on the right.

LIE to Exit 63 (North Ocean Ave). Make a left on Hawkin's Path (2nd light after crossing over Rte. 25). Stay on Hawkin's Path and make a right onto Howe Rd.

Nichol's Road (CR 97) North to Oxhead Rd. (1 light north of 347). Make a left onto Oxhead Rd. R.C. Murphy JHS is on the right

Long Island Expressway to exit 49 (Rt. 110). Go north on Rt. 110 through Huntington. Rt. 110 becomes New York Avenue. Make a left onto Mill Dam Road fields will be on the left.
